IS MY DRINKING WATER SAFE? Hartstene Pointe Water-Sewer District meets or exceeds all Federal and State water quality standards. Each month the trained staff takes a sample from the distribution system to test for coliform bacteria. Of the 12 samples that were taken in 2022, **none** were unsatisfactory.

WHAT IS THE SOURCE OF MY DRINKING WATER? Your water comes from our two 160 foot deep wells, which pump 30 and 60 gallons per minute respectively. Our drinking water is chlorinated and treated to remove Arsenic, Iron and Manganese.

WHY ARE THERE CONTAMINANTS IN MY DRINKING WATER? Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily mean that water poses a health risk. HARDNESS The hardness of the District's water from Well 4 is 97.0 mg/l and is measured by Standard Methods 2340B. The range for moderately hard water is 51.3 to 119.7 mg/l or 3.5 to 7 grains per gallon.

IS OUR WATER SYSTEM MEETING REGULATIONS THAT GOVERN OUR OPERATIONS?

Yes. The State and EPA require us to test our water on a regular basis to ensure its safety. The District completed construction of the new treatment facilities for both wells in August of 2017. The District continues to fine tune the treatment process for the removal of Arsenic and the current twelve month running average is 5.7 parts per billion.

DO I NEED TO TAKE SPECIAL PRECAUTIONS? Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, as well as some elderly and infants can be particularly at risk from infections. WATER QUALITY DATA The enclosed tables list all the drinking water contaminants that we detected during the most recent sampling. The presence of these contaminants in the water does not necessarily indicate that the water poses a health risk. The data is a compilation of the individual well data. The State of Washington does not require us to monitor for certain contaminants every year because the concentrations of these contaminants are not expected to vary from year to year.

Maximum Contaminant Level or MCL: The highest level of a contaminant that is allowed in drinking water. MCL's are set close to the MCLG's as feasible using the best available treatment technology.

Maximum Contaminant Level Goal or MCLG: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLG's allow for a margin of safety.

Maximum Residual Disinfectant Level or MRDL: The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Maximum Residual Disinfectant Level Goal or MRDLG: The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

* The Maximum Contaminant Level Goal (MCLG) listed for arsenic, copper, and lead are levels above which the District must take corrective action. The action level for lead and copper must be exceeded by at least two samples out of ten taken.

Lead: In Washington State, lead in drinking water comes primarily from materials and components used in household plumbing. The more time water has been sitting in pipes, the more dissolved metals, such as lead, it may contain. Elevated levels of lead can cause serious health problems, especially in pregnant women and young children. To help reduce potential exposure to lead: for any drinking water tap that has not been used for 6 hours or more, flush water through the tap until the water is noticeably colder before using it for drinking or cooking. You can use the flushed water for watering plants, washing dishes, or general cleaning. Only use water from the cold-water tap for drinking, cooking, and especially for making baby formula. Hot water is likely to contain higher levels of lead. If you are concerned about lead in your water, you may wish to have your water tested. *****Arsenic:** Water from both wells exceeds the arsenic maximum contaminant level (MCL) and has a state approved treatment system to lower the level of arsenic to an acceptable level. Only One of the Twenty Four samples taken during the year registered an Arsenic level above the MCL of .010 ppm or 10 ppb. On January 11th, the sample from Well 4 resulted in .011mg/L or 11 ppb. It is not considered a Violation due to the running annual average of all samples taken. The annual average from Well 2 is .004mg/L and Well 4 was .0075mg/L. The combined average from both wells are .0057mg/l or 5.7ppb.

With the treatment, our drinking water currently meets EPA’s revised drinking water standards for arsenic. There is a small chance that some people who drink water containing arsenic for many years could develop circulatory disease, cancer or other health problems. Most types of cancer and circulatory diseases are due to other causes than exposure to arsenic. EPA’s standard balances the current understanding of arsenic’s health effects against the cost of removing arsenic from drinking water. **WAIVERS:** The Washington State Department of Health has reduced the monitoring requirements for herbicides, insecticides, and pesticides because our sources are not at risk of contamination.
