
Special Meeting Announcement

Water System Flushing



The crew will be performing quarterly flushing April 8-19. A reminder: please give the crew plenty of space so that they can safely perform this task.

You may experience a brief period of low water pressure when flushing is taking place near your property. Flushing is a common practice in a lot of older water distribution systems and helps clean the water main lines, so that we can deliver the best drinking water to your home.

If you notice any discolored water coming from your tap during this time, run water until it turns clear.

Thank you for Attending Meeting, Providing Feedback

Thank you to those who were able to participate in the District's latest meeting (an estimated 55 community residents) where the Wastewater Infrastructure Rehabilitation Project (WIRP) engineers provided project updates to the community. Following the conclusion of the meeting, District Staff & Commissioners received correspondence with questions and feedback from a number of residents, which are discussed at commissioner meetings.

Ecology Visits Wastewater Treatment Plant

The Dept. of Ecology regulates wastewater systems in the state. This includes certifying operators, approving design plans (e.g. the upcoming sewer project) and the wastewater treatment plant (WWTP). Every month, District staff submit reports with data that includes daily and weekly laboratory tests of incoming sewer water and treated discharge to the Sound. Ecology reviews results to ensure the WWTP is in compliance with the District's discharge permit. While these are just numbers, periodically Ecology performs site visits, most recently this past January. Ecology published

their report conveying satisfaction with our operations and noting they are pleased regarding the upcoming sewer project. The report is available on our website:
