# A RESOLUTION OF THE HARTSTENE POINTE WATER-SEWER DISTRICT COMMISSIONERS ESTABLISHING A PETTY CASH ACCOUNT, APPOINTING A CUSTODIAN, DESIGNATING A DEPOSITORY AND ESTABLISHING THE AMOUNT OF MONIES

WHEREAS, the system of accounting mandated by the State Auditor's Office of the State of Washington prescribes that all petty cash accounts be established by Resolution or Ordinance (per the Washington State Budget, Accounting, Reporting System (BARS) Manual); and

WHEREAS, a petty cash account is defined as any sum of money or other resources set aside for specific purposes including minor disbursements; and

WHEREAS, the governing body must authorize the amount held in each petty cash account and all subsequent increases or decreases in the petty cash account amounts; and

WHEREAS, the governing body must appoint one custodian who should be independent of invoice processing, check signing, general accounting and cash receipts functions; and

WHEREAS, the custodian is personally responsible for the value of the fund and to ensure that all policies and procedures are adhered to; and

WHEREAS, petty cash funds shall be replenished at least monthly; and

WHEREAS, the custodian shall be covered by a surety bond in the amount of the account or covered by an insurance policy covering honest and faithful performance.

**NOW, THEREFORE,** be it resolved by the Board of Commissioners as follows:

**Section 1.** Authorization. A petty cash account is hereby authorized for the purpose of minor and unanticipated disbursements. The account shall be in the amount of \$1,000.00 with the Custodian being the District General Manager.

<u>Section 2.</u> Fund Depository. The District shall authorize West Coast Bank, Shelton Branch located at 2307 Olympic Hwy N. in Shelton, WA as the designated

depository of petty cash funds and adopts by reference the attached Corporate Banking Resolution.

Section 3. Procedures. The Board of Commissioners shall adopt procedures and policies appropriate to implement provisions of this resolution and within requirements prescribed by the State Auditor's Office. Such procedures shall include but not be limited to, (1) defining limitations on the use of the petty cash account, and (2) providing accounting and reporting procedures for operation, reconciliation and replenishment of the petty cash account, and (3) policies for debit card use.
