Water Plant Improvements Will Begin This Fall

Following more than four years of planning and design, the District's Water Treatment Plant Improvements project will be underway this fall. The project will optimize the water treatment process by replacing outdated, inefficient, and failing drinking water treatment equipment. The result will be improved drinking water quality and treatment effi-

ciency, increased water source flexibility, and water conservation.

The project will include replacement of failing water filtration and control systems, the addition of water quality monitoring equipment, and an upgrade of the SCADA system to allow remote real time monitoring, providing a better response time to equipment issues.

The \$1.3 million project is being paid for with a 20-year, 1.5% interest loan through the Drinking Water State Revolving Fund.

The contractor for the project has been selected and construction will begin this fall. The water system improvements should be completed this winter.

Well Replacement Update

The District has awarded the contract for drilling of the Well 1 replacement. The project is slated to begin in late September. We had hoped to begin drilling sooner, however the District's original request for quotes produced only one bid, therefore the project was re-bid in order to produce multiple quotes.

The replacement well will increase water production. In the past, Well 1 produced 50 gallons per minute (gpm), however current production is averaging only 35 gpm. The new well will be designed to produce its water right of 110 gpm, or upwards of 108,000 additional gallons of water per day. With proper maintenance, the new well should last 50 years or longer.

During the well drilling, residents can expect loud noises emanating from the drill site throughout the Pointe. Construction will take place no earlier than 8:00 am and no later than 5:00 pm.

Until the new well is on-line, the District asks homeowners, renters, and guests to take extra care to conserve water. Visit our website, hpwatersewer.com, for water-saving tips.

Drippy the Droplet's Water-Saving Tip:

"To cut down on water waste, put two inches of sand or pebbles inside each of two plastic bottles to weigh them down. Fill the bottles with water, screw the lids on, and put them in your toilet tank. This can save ten or more gallons of water per day."
