At the November 13th meeting the Board of Commissioners adopted the District's 2015 annual budget.

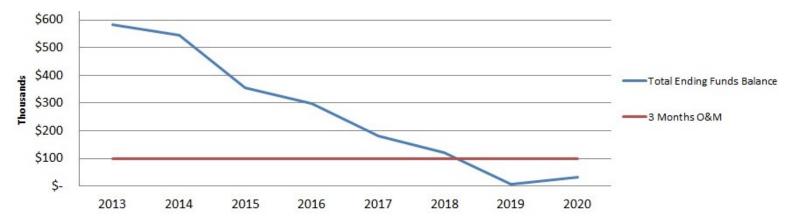
There is a 3% decline in operating expenditures between the 2014 and 2015 budgets, despite rising costs in electricity, insurance, and other expenditures.

The Water Treatment Upgrade Project will be wrapping up in 2015. The District's first annual payment on the project loan, estimated at \$40,000, will be due in October, increasing the District's annual Debt service obligations by 50%.

#### 2015 Budget Adopted (continued)

The District has been working to keep costs down, however, due to ongoing efforts to address deferred maintenance and capital improvement, there is a projected net loss for the second year in a row. This trend persists in the six-year financial projections for the District at the current service rates. There will not be a rate increase for 2015, however the District will need to address its declining cash balance in its 2016 Budget planning.



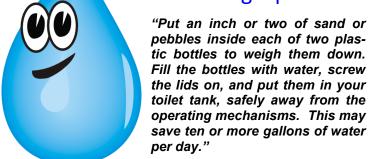

#### **Public Works Board Training**

Commissioner Nancy Nelson and the District's Accounting and Administrative Services Manager, Miceal Carnahan, recently attended a free training put on by the Washington Public Works Board. Topics covered in the training included budgeting, rate studies, creative infrastructure funding, and energy efficiency. Both of the District's attendees agreed that it was a very valuable training, providing fresh ideas and insights for water/sewer system management.

The District is continually seeking out training opportunities such as this one to keep up-to-date on regulations and requirements as well as industry best practices and sound financial management. The commissioners and managers will be attending The Washington Association of Sewer and Water District's annual Commissioner's Workshop later this month.

#### Please Report Leaks

#### **District Receives Refund**

The District's Accounting and Administrative Services Manager, while studying the State's WACs regarding Public Utility Taxes, discovered that the District, since its inception, had been paying too much to the state in excise taxes. The District was able to amend its state tax returns from 2010 through 2014. The total refund amount received by the District for the amended filings totaled \$26,592.29 plus \$935.08 total interest.

Additionally, going forward the District will pay approximately \$7,000 less every year in state taxes, a 33% reduction.
