# HARTSTENE POINTE WATER-SEWER DISTRICT General Manager's Report February 9, 2017

## Water

- 1. The HPMA maintenance staff repaired the 4" water line to the marina.
- 2. The daily water production is running at approximately 48,000 per day. We are operating with Well 1 as the primary source and operating Well 2 manually to supplement daily demand.

## **Drinking Water Treatment Upgrade**

- 1. 2KG Construction has completed the new structure foundations for both sites and has completed the preliminary construction of the structures.
- 2. 2KG Construction has submitted a change order for the interior water proof liner backing installation in the amount of \$8,548.08. The original contract called for new insulation and the liner but not for backing where a solid surface doesn't exist. The liner is thin and is intended to be applied with adhesive to a solid surface. Sean at RH2 and I are investigating/discussing the proposal with 2KG.
- 3. Chris Roberts Electrical Engineer for RH2 and I will be in attendance at Evolution Controls shop for the testing of the new treatment control system and the new SCADA software today.

## Well 1 Replacement

1. We have received all the water quality test results and Steve Nelson Hydrologist for RH2 Engineering is finishing up the drilling and testing report for Well 1R.

## **Sewer Collection**

1. David has been locating previously unidentified manholes and adding them to the GPS asset map. We will be checking flows at the manholes to identify areas in need of further investigation for potential I & I sources.

## **Waste Water Treatment**

1. Influent flows have increased due to the recent rain events requiring additional monitoring and management of the treatment processes.
