#### MINUTES

**PRESENT:** Secretary M.A. Cary, Commissioner D. McNabb, Accounting and Administrative Services Manager (AAS) M. Carnahan, General Manager (GM) M. Jeffreys.

**CALL TO ORDER:** The meeting was called to order at 1:00 pm.

**SUBSCRIBER REMARKS:** Andrew Hospador and Roger Ray present. Andrew Hospador asked if the District flow meters. GM said the District does not. The GM has looked into purchasing some for measuring flows in sewer manholes, however they are very expensive.

#### **BUSINESS:**

2015 Annual Report: Presented and discussed. The 2015 Annual Report to the State Auditor's Office was reviewed by Heather Frederickson of Mason County Fire District 4, based on the recommendation from the State Auditor's Office that the District have someone knowledgeable in BARS and independent of the preparation of the report. Commissioner McNabb moved to approve the independently reviewed 2015 Annual Report as presented. Commissioner Cary seconded. Hearing no objections, the motion passed.

South Shore Excavation Sewer Line Repair Proposal: Presented, in the amount of \$2,712.50. Commissioner McNabb moved to accept the proposal. Commissioner Cary seconded. Hearing no objections, the motion passed.

**Public Works Contracting Resolution:** The AAS proposed the District update its public works contracting policies. Policies were discussed. AAS will present a draft public works purchasing and bidding resolution for the next meeting.

Pressure Reducing Valve Replacement Project: RH2 proposed performing the engineering for the Pressure Reducing Valve Replacement under the District's General Services Contract with RH2, not to exceed \$6,000. Commissioner McNabb moved to approve the engineering for the Pressure Reducing Valve Station Project proposal, not to exceed \$6,000. Commissioner Cary seconded. Hearing no objections, the motion passed.

Current Projects Review: GM updated the Board on the status of the current District projects. Commissioner Cary moved to authorize the GM to negotiate a contract not to exceed \$6,000 for asphalt repair on Pointes Drive East. Commissioner McNabb seconded. Hearing no objections, the motion passed.

Education: I received both B.E.E. and M.Eng. (Elec) from Cornell University, Ithaca, NY, and continued taking courses in computer languages (C++, Pascal, COBOL, BASIC) and business at University of Rochester, Rochester, NY, Cedar Crest College, Allentown, PA and Desales U., Center Valley, PA.

This letter is in regards to the contract that we are in the process of creating, if both parties agree on terms, I am willing to work with you on this wastewater plant, I just want to make sure we are on the same page on a few things, and that we are clear on all the rest.


This is a kind of proposal from me, for I am still a little in the dark on things as far as the condition of the plant, and need to know the entirety before I go all in with no direction. I did do a quick tour with Mont at the plant and found numerous things around the plant and in the laboratory that are out of permit and compliance, i.e. expired lab chemicals, non-working effluent composite sampler, (a weekly permit requirement), jet pumps repaired but not installed yet. There are quite a few things just in the quick tour that I picked up on so I'm sure once we dive deeper, we will find numerous more things that need attention. I'm up for the challenge, these are all things I'm familiar with and as a licensed operator, have an obligation to perform these tasks and stay in compliance to the best of my ability.

There are a lot of specifics we can go over if needed. I am currently enrolled in and using web-dmr, as required on your new permit, and am up to date on lab training and record keeping, as well as compliance. I also spoke with Mont about creating and utilizing a preventative maintenance program for the wastewater plant to prolong wear of equipment and save money for years to come with proper utilization on the program.

I don't feel that a single hour every day is enough time at all to successfully operate your plant. To successfully maintain and operate it daily, I couldn't give a time because every day is different and can bring something new, making the day go on for hours some days.

The single negative thing for me on this is the 7 days a week schedule, it's a huge commitment. At this time in my life, this is something I can deal with. I've turned plants around before to receive outstanding performance awards, 3 in the past 2 years... I do my job fully committed. I have a current up to date Wastewater license as a group 2 operator #8225, a Water Distribution Specialist 1, and a Cross Connection Control Specialist #013074. My Business is MDG Wastewater & Water Treatment UBI 603330001.

To accept the operator job at Harstene Pointe, I am requesting a monthly salary of \$3500.00 per month. This would include maintaining the necessary license to legally work at the plant, operating within compliance and regulations through Department of Ecology. Doing all the required sampling, record keeping, Web-DMR, plant operations, aside from major repairs, creating a preventative maintenance schedule... and utilizing it, and lots more organization. I am physically fit and capable for the job ahead. We can meet and go over more specifics if needed. I am ready as soon as you need me.
